6:45-6:50 Commissioner Amanda Fritz, upcoming bond measure Measure 26-159 "Fix Our Parks". Bond will go towards maintenance and improvement, no new projects.

7:00-7:05 Aaron Sorenson- updated information on the new homes at 65th St & Holgate. Everett Custom Homes had originally said that on-site parking was planned (presentation at our meeting in March). Recent plans sent to immediate neighbors had no on-site parking. Aaron and other interested neighbors contacted Everett, requested parking, to which they added on 1 car parking pads to the back of all the lots, accessible by the back alley. A request was made to write a letter to Everett Custom Homes, requesting 2 car parking spaces per lot (many concerns about on-street parking), and also requesting they work with Rose CDC and/or look into other avenues to offer houses at affordable or even fair market rates.
