6:27 Welcome and introductions

6:30 Sergeant Gunderson from **PDX Police SE Precinct** is here to answer questions as Officer Bacon is not available. He reports that homeless camps continue to be problematic along the Springwater Corridor and the 205 Bike Path. Homelessness is not a crime; however, drug use, theft, assault, arson, and other types of criminal behavior will be dealt with by PPD. "One Point of Contact" has been created for dealing with homelessness: 503-823-400. Changes in Police Bureau are underway, to follow changes with Mayoral office. "Trespass Agreement" discussed as an option for businesses to deal with campers or nuisances on their property – contact Officer Teig at 503-823-4800 to set this up.

6:43 Presentation by Chester Anderson of **Zipcar**. Zipcar would like to increase presence in Foster-Powell. Zipcar is now offering a one-way model (similar to Car to Go) with Honda Fit cars. Here to assess community desire for this service.

6:50 Corbett and Brad Blake from **Portland Water Bureau** are here presenting on aid for families in need. Quarterly discounts, crisis voucher, and fixture and repair assistance are available. Water saver kits are available. Monthly bill options are available.

6:55 Presentation by Marty Stockton, SE Portland City Planner, with Bureau of City Planning. Provides overview on **mixed used zones project**. Historically, housing was always allowed in commercial zones. Last review of zones was 1992. Switching to 4 mixed use zones. Some areas proposed to be zoned to limit buildings to 3 stories. Foster from 63<sup>rd</sup> to 67<sup>th</sup> is part of proposed change, however, this will likely be removed from the proposal as a result of response from local businesses. They are requesting testimony in support or opposition to zoning changes. Accepting submissions of testimony by July 12<sup>th</sup>.
